**11^H ANNUAL RAUSBC OPEN CITY
TOURNAMENT RULES**

1. All NM USBC bowlers are eligible to enter. *Collegiate and military personnel who have permanent addresses in our jurisdiction would also be eligible to bowl if they are members of our association through a league or if they qualify under USBC Constitution, Article 5.*
2. Handicap: The handicap will be based on 90% of 210.
3. Multiple Participation: First appearance in each event shall count toward all-events. The highest score in each event will be used to qualify for the Master's Tournament. Bowlers may participate as often as the schedule permits. In no case shall an individual or same doubles team cash more than once. Not more than 3 players on the same team can place more than once in the prize list for team standings. Do not overlap time schedules.
4. Awards: Chevrons will be awarded to handicap winners in each event. Cash prizes will also be awarded in each event (at least 1 for each 7 entries) on a handicap basis only. An entrant who qualifies for all-events and has not paid the optional \$7.00 fee will not be eligible for the all-events cash award. There will be 2 divisions in Singles: 180 & up & 179 & below. There will be 3 divisions in All-Events: 180 & up / 179 & below / Seniors only.
5. Entering Averages: 10-pin rule will apply. Use 2015-2016 season highest book average as of 21 games. If you're current season's average as of January 1, 2017 (for 15 games or more) is 10 pins or more higher than last year's average you must use this year's average. Entrants who do not have a 2016-2017 book average must use their highest 15 game average as of the time of the participant bowls the tournament. All other will bowl scratch. All bowlers who do not qualify above are subject to Tournament Committee approval.
6. Attention: It shall be each bowler's responsibility to verify the accuracy of her average. Failure to submit the correct average will result in scores being adjusted to reflect the correct average and handicap. Bowlers who have qualified for prizes of \$600 or more (cash and/or merchandise) in an event in a tournament within the last 12 months must comply with USBC Rule 319c. All prizewinner's averages will be verified.
7. Check in time will be 30 minutes prior to squad time.
8. Any protest or appeals affecting eligibility or playing rules must be confirmed in writing to a tournament official or to USBC prior to any prize pay out.
9. In case of mechanical failure, bowlers will be moved to the first available pair of lanes.
10. Deadline: Closing date for entries is Thursday, February 16th, 2017 @ 9pm. LATE entries will be accepted on each squad time upon lane availability.
11. The Tournament Committee shall have the right to reschedule bowlers at its discretion.
12. Checks or money orders are to be made payable to RAUSBC.
13. All rules not specifically covered will follow the USBC rulebook.
